<p><b>Brief description of nature and extent of development, including uses</b></p>	<p>The proposed development will consist of a Large-Scale Residential Development (LRD) comprising of the following: (1) the demolition of a terrace of 4no. existing dwellings, 3no. of which are derelict, and ancillary sheds and their replacement with 1no. single-storey 3-bed detached bungalow (116sqm.) accessed via a modified private driveway; (2) the construction of 103no. dwellings (10980.6sqm.) (18no. 1-beds, 9no. 2-beds, 68no. 3-beds, and 8no. 4-beds) of between 2-4 storeys in height, to include 50no. townhouses (3no. 2-bed units; 39no. 3-bed units and 8no. 4-bed units); and 53no. duplex apartments (18no. 1-bed apartments, 6no. 2-bed apartments, and 29no. 3-bed apartments); (3) The proposed development will also include a ground floor crèche (217.4sqm.) with rear garden and front set down area.
