IRISH WILDFLOWER MEADOW		
Meadow areas to be mowed every 4-6 weeks, with the cut removed. This gives a succession of naturally occurring wildflower seeds a chance to grow, such as Dandelion, Clovers, Bird's-foot-trefoil, and Selfheal. Best practice is to cut after Dandelions in April, in early June and in mid-July. Grass cuttings to be lifted after mowing to allow meadow to become more flower-rich on its own.		
Herbicides are not to be used. These chemicals can negatively impact soil biodiversity. Any problematic weeds to be removed manually. Signage can be used to show deliberate reduced mowing regime.	encouragement through management regime

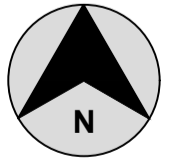
